- Docks
- o We have had some dock damage during the last couple wind storms. Nothing major.
- Sandbar
- We have called our Port-a-Johnnie supplier to have them removed. We only pay for them until the 15th of September.
- O We are done mowing and raking the sandbar.
- o All trash cans have been secured.
- O The sandbar shed has been boarded up.
- Employees
- O We are working with 2.5 people on our maintenance crew. We will get through the shutdown okay.
- Shutdown
- We will start shutting down on October 16th.
- Water and electricity will be shut off by October 18th.
- We hope to pull channel markers next week, weather permitting.
- O Jet ski docks will be pulled next week. O The sewer pump at the fuel dock has been winterized.

o We are working with several dock manufacturers to get a replacement cost for "B" dock in PCM. This replacement will not take place in 2025 due to availability of funds and manufacturing schedules. We hope to remove the old dock in the Fall of 2025 and put in the new dock in the Spring of 2026.

o As of Tuesday October 15th we had 7 boats in PCM and 37 boats in the Lagoon.

Sandbar gate:

The sandbar is one area where we lose profit. This year we were able to keep labor costs down by only operating Thursday-Sunday. This was unpopular as people would like to drive out on the other days. A pay gate is a way to capture the revenue on those days without the expense of labor.

Concerns are cost of the gate and policing of behavior out on the sandbar. We will start to look at costs.

We have ice cream left over from the fuel dock, last year Oasis donated the ice cream to a local group. It has been suggested that this year we donate to the Corpus Christi Faith Formation.

State Capital Budget funds:

We have two options on ways to go with these funds: Option 1: Is to complete the design and construction documents on the New Marina Project. This will also allow us to request reimbursement on all of the permitting expenses that have already been incurred. This will allow for a beginning cash flow to work with as this is a reimbursement grant. I can also apply for the funds to replace the old style jet ski docks. This will allow us to be competitive for additional funding as the project will be shovel ready. Option2: We can create a compilation of all of the marina repair projects. We have a bunch of projects that need completed however we may not have the cash flow to fund these up front. Option one has the better potential.

Parking lot: Bill was approached by someone interested in purchasing the parking lot.

The board would entertain the option of selling the lot for no less than what we have into it or leasing it out.
